- Customer shall not be entitled to the Total Credit Amount or any balance thereof and shall pay SmarTone Mobile Communications Limited ("the Company") Liquidated Damages specified above upon the occurrence of any of the following circumstances before the expiry of Term:
 - if Customer changes the mobile telephone number of Registered Plan / Transitional Plan/Teen 地派 plan; or
 - if Customer changes the registered name of Registered Plan / Transitional Plan / Teen 地派 plan; or
 - if Customer changes the selected Registered Plan / Transitional Plan / Teen 地派 plan (other than Service Plan as specified); or
 - if Customer terminates the payment method specified in Registered Plan / Transitional Plan / Teen 地派 plan;
 - if the mobile telephone service to the mobile telephone number of Customer / Teen 地派 is terminated/disconnected for whatever reason.
- If, on the date of this Sales & Services Agreement, the Account is already subject to an arrangement ("**Previous Credit Arrangement**") under which any sums or charges prepaid by the Customer are to be credited by the Company to the Account, the crediting of the first installment to the Account by the Company under this Sales & Services Agreement shall be postponed to the date falling 30 days after the date of cessation of: (a) the Previous Credit Arrangement; or (b) if there is more than one Previous Credit Arrangements, the Previous Credit Arrangement with the latest expiry date.
 The date of cessation of the Previous Credit Arrangement will be deemed to be the date on which the last amount to be credited to the Account under the Previous Credit Arrangement is actually credited to the Account.
- The Credit Amount paid by the Company will only be applied by the Company to meet the Customer's payment obligations to the Company in respect of the Account. However, the Customer cannot set-off any other sum payable to the Company against any part of the Credit Amount payable by the Company to the Account.
- The Credit Amount cannot be exchanged for cash.
- The Company shall not be under any obligation to pay any interest to the Customer on the Credit Amount.
- If the handset purchased by the Customer under one of the Company's special offer fixed term contract is SIM-locked and can only be used with the Company's SIM card, the Company will not unlock the SIM lock for the Customer if the SIM lock has already been altered or tampered with by an unauthorized person(s), and the warranty of the handset will be void. Any subsequent servicing or repair request will be subject to a payment in advance of an inspection and testing fee of HK\$2,000, in addition to any charges for parts and labours.
- If the Customer requests the SIM lock which is pre-set by the Company to be unlocked before the expiry of the Term, the Customer shall pay the Company an administration fee of HK\$400 for such services.
